

RESOLUTION NO. 2025-399

A RESOLUTION AWARDING A CONTRACT TO WAMPOLE-MILLER INC., DBA MILLER BROTHERS, CONSHOHOCKEN, PA, FOR PRIMARY CIRCUIT CONSTRUCTION FOR THE LANDFILL SOLAR PROJECT.

WHEREAS, the City of Vineland has heretofore advertised bids for Primary Circuit Construction for the Landfill Solar Project, COV BID #2025-20, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on July 10, 2025, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of August 12, 2025 submitted a written report and tabulation of the bids received and has recommended that a contract for Primary Circuit Construction for the Landfill Solar Project, be awarded to Wampole-Miller Inc., dba Miller Brothers, Conshohocken, PA, in the amount of \$2,512,930.00, plus a 20% contingency in the amount of \$502,586.00 for a total amount of \$3,015,516.00, said bid being the lowest responsive responsible bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for Primary Circuit Construction for the Landfill Solar Project, COV BID #2025-20, be and the same is awarded to Wampole-Miller Inc., dba Miller Brothers, Conshohocken, PA, and their total bid in the amount of \$2,512,930.00, plus a 20% contingency in the amount of \$502,586.00 for a total amount of \$3,015,516.00, said bid being the lowest responsive responsible bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the City Comptroller has certified that the funds for the contract to be awarded herein are available.
