RESOLUTION NO. 2025- 660

A RESOLUTION AWARDING AN OPEN-ENDED CONTRACT TO RESA SERVICE, LLC, FARMINGDALE, NJ, FOR THE PURCHASE OF CIRCUIT BREAKERS FOR VMEU-GENERATION, IN THE AMOUNT OF \$187,240.00.

WHEREAS, the City of Vineland has heretofore advertised for bids for the purchase of Circuit Breakers for the Vineland Municipal Electric Utility-Generation, for a period of one year, in accordance with specifications on file in the office of the Purchasing Agent, COV BID #2025-31 (RE-BID); and

WHEREAS, on November 13, 2025, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report, and recommendation; and

WHEREAS, the Business Administrator has, under date of December 16, 2025, submitted a written report and tabulation of the bids received and has recommended that an open-end contract for the purchase of Circuit Breakers for the Vineland Municipal Electric Utility- Generation, COV BID #2025-31 (RE-BID), be awarded to Resa Service, LLC., Farmingdale, NJ, in the amount of \$187,240.00, said bid being the lowest responsive responsible bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said open-end contract for the purchase of Circuit Breakers for the Vineland Municipal Electric Utility- Generation, COV BID #2025-31 (RE-BID), for a period of one year, be and the same is awarded to Resa Service, LLC., Farmingdale, NJ, in the amount of \$187,240.00, said bid being the lowest responsive responsible bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and


BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
