RESOLUTION NO. 2026- 32

A RESOLUTION AWARDED A CONTRACT WITH INVOICE CLOUD, INC., BRAINTREE, MA, TO PROVIDE ONLINE PAYMENT PROCESSING SERVICES FOR VINELAND MUNICIPAL UTILITIES.

WHEREAS, the City of Vineland has heretofore advertised for proposals for the Online Payment Processing Services, COV RFP #2025-39, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on December 3, 2025, proposals were received, duly opened and read aloud, being referred to the IS Division for evaluation and recommendation; and

WHEREAS, it has been recommended that a contract for the Online Payment Processing Services, be awarded to Invoice Cloud, Inc., Braintree, MA, for the required services for a period of one year commencing January 1, 2026, with option to renew for 3 one-year periods, based upon the proposal received, pursuant to a fair and open process; and

WHEREAS, payments for said services provided shall come from a Customer Convenience Fee paid directly to Invoice Cloud.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Vineland that the Mayor and Clerk of the City of Vineland are authorized to execute a Contract with Invoice Cloud, Inc., Braintree, MA, to provide Online Payment Processing Services for the Vineland Municipal Utilities, for a period of one year commencing January 1, 2026, with option to renew for 3 one-year periods, based on their proposal pursuant to fair and open process and considered in the best interest of the city.
